GRANT OF SHARE OPTIONS

This announcement is made by Vincent Medical Holdings Limited (the “**Company**”) pursuant to Rule 17.06A of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company hereby announces that on 28 May 2018 (the “**Date of Grant**”), the Company has granted 14,300,000 share options (the “**Share Options**”) to the eligible participants (the “**Grantees**”) under the share option scheme of the Company adopted on 24 June 2016 (the “**Share Option Scheme**”). Subject to acceptance by the Grantees, the Share Options will entitle the Grantees to subscribe for an aggregate of 14,300,000 ordinary shares of HK\$0.01 each in the share capital of the Company (the “**Shares**”).

Number of the Share Options granted:	14,300,000 Share Options (each Share Option shall entitle the holder of the Share Options to subscribe for one Share)

Validity period of the Share Options:	28 May 2018 to 23 June 2026 (both days inclusive) subject to the provisions for early termination contained in the Share Option Scheme and certain vesting conditions applicable to the relevant Grantees
Vesting schedule and exercise period of the Share Options	25% of the Share Options will vest on each of 28 May 2019, 2020, 2021 and 2022 respectively and will be exercisable from each of 28 May 2019, 2020, 2021 and 2022 respectively to 23 June 2026
